**Mayor's Report**

Council member Sleezer moved to approve a three-year contract with Allied Waste Services of Cherryvale for residential solid waste collection services, beginning March 1, 2010 and terminating Feb. 28, 2013, with the rate of payment during the first year set at \$11.54 per month for each single residential dwelling unit and a minimum annual increase of 3 percent on the anniversary date. Council member Harkrader seconded. Motion passed 5-0.

No sealed bids were received for the city hall building.

The council received information about a League of Kansas Municipalities Regional Supper November 18 in Chanute. The cost is \$12.00 per person.
