

ORDINANCE NO. 2009-06

AN ORDINANCE INCREASING WATER RATES IN THE CITY OF NEW STRAWN, KANSAS; PROVIDING FOR AND FIXING THE RATES TO BE CHARGED FOR WATER SOLD BY THE CITY OF NEW STRAWN, KANSAS; AMENDING SECTION 12-111 OF THE CODE OF THE CITY OF NEW STRAWN, KANSAS, AND REPEALING SAID SECTIONS AS THEY EXISTED PRIOR TO THE ADOPTION OF THIS ORDINANCE;

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF NEW STRAWN, KANSAS:

SECTION 1. Section 12-111 of the code of the City of New Strawn, Ordinance No. 2003-12 of the City of New Strawn, Kansas is hereby amended to read as follows:

Section 12-111 WATER RATES

(a) Consumers shall pay the following water rates for water furnished them within the City limits of New Strawn:

- (1) Thirty Dollars (\$30.00) - for a water system maintenance fee;
- (2) Eight and 75/100 Dollars (\$8.75) per thousand gallons.
- (3) The minimum monthly water charge shall be Thirty-eight and 75/100 Dollars (\$38.75).

(b) Consumers shall pay the following water rates for water furnished outside the City limits of New Strawn:

- (1) Thirty Dollars (\$30.00) for a water system maintenance fee;
- (2) Thirteen and 10/100 Dollars (\$13.10) per thousand gallons.
- (3) The minimum monthly water charge shall be Forty-three and 10/100 Dollars (\$43.10).

(c) All retail water consumers shall pay a state water protection fee at the rate of 3 cents per 1,000 gallons.

SECTION 2. That Section 12-111 of the Code of the City of New Strawn, as amended herein, and all such sections existing prior to the adoption of this Ordinance, are hereby repealed.

SECTION 3. The provisions of this Ordinance shall be included and incorporated in the Code of Ordinance of the city of New Strawn, Kansas, 1986, as an addition or amendment thereto, and shall be appropriately renumbered to conform to the uniform numbering systems of the Code.

SECTION 4. This Ordinance shall become effective for the next billing cycle and be in full force and effect after its publication in the official city newspaper, The Coffey County Republican.
